Copies of letters which were addressed to Noble Environmental and DEP from the County Commissioners opposing the proposed transfer station in Snyder Township were presented to the Board.

Jefferson County Solid Waste Authority asked for a donation consideration during 2026 budget preparations.

Keller Engineers sent notice of Brockway Borough's intent to submit an application to the DEP for a water system improvement project of replacing several existing water lines.

Horton Township provided the Board with a copy of their Quality of Life Ordinance.

The minutes from the September meeting were approved as read.

The October Treasurer's Report was read with balances as of November 1, 2025. General Fund balance \$602,785.16; Liquid Fuels Fund balance \$57.71.
