

**Snyder Township Board of Supervisors**  
**Regular Monthly Meeting**  
**December 23, 2025**

The minutes from the November Meeting were approved as read.

The December Treasurer's Report was read with balances as of December 27, 2025. General Fund balance \$515,361.71; Liquid Fuels Fund balance \$85.11. Michael Holt motioned to endorse Jake Rindosh as Township Representative on the Brockway Recreation Board, with Ronald Freemer second. All supervisors voted yes and the motion carried.
